Forming Committees to Deport the Displaced People of Syria! The Inquisition of the 21st century

(Translated)

In light of the political power renouncing all its economic, security and humanitarian responsibilities towards the people of the country, its absence from all the major and minor files, confining the official positions in the conflicts between the leaders of sectarian militias, and the struggle to share sectarian quotas, Iran's Party in Lebanon and the Free Patriotic Movement have been setting up internal committees which aim to deport our people from Syria in an abhorrent racist and sectarian process.

These committees remind the humanity of the Inquisition that practiced the forcible deportation of the Muslims of Andalusia!

Though we are aware of the extent of the racism of the Free Patriotic Movement **towards Muslims** and are aware of the extent of the criminality of the Iran's party in Lebanon and that it has transformed into a Blackwater-like institution in abhorrent sectarian cover, but the word of truth must be spoken in the face of those who **commit crime against our people the Muslims from Syria who have been displaced:**

First: Lebanon is a Muslim country, and soon it will return to be part of the Islamic State, the Khilafah (Caliphate) on the methodology of the Prophethood, despite France and America and their racist cronies in the region.

Second: the formation of these committees will soon be a scourge on those who formed them. It is as we have repeatedly stated, that the racist discourse - although today ostensibly directed against our people in Syria - we begun to see it being translated into a sectarian conflict between the people of the country.

Third: Has the prime minister-designate become a false witness to the state of decline of the political discourse, which is moving from bad to worse? Why he doesn't put an end to this?

Fourthly: Whoever attributes the deterioration of the economic situation in the country to the presence of our displaced people is a sinful liar. This is a **fabricated lie**, **rather a delirium** and contempt for the minds of the people of the country. As everyone knows the extent of corruption and thefts committed by the leaders of the communities since France detached Lebanon from its Islamic surroundings and that the size of debt has increased well before the beginning of the Syrian revolution!

Our people who have been displaced from Syria are our brothers in religion, relations and kinship. So, Muslims in Lebanon should not accept this situation or make this injustice pass through the chorus of the shameful appropriations of the country and its people by the government and its ministries.
